Aim and scope of the Conference

This conference is intended to study and disseminate the international law applicable to Peace Operations.

For the purpose of this conference, Peace Operations are defined as those military operations which legally require the consent of the Host State in order to be able to deploy and operate on that State's territory and which are additionally subject to the principles of impartiality and restricted to the use of force in self-defense. In addition to the legal requirement of Host State consent, peace operations are also dependent upon the consent, or at least acquiescence, of all the parties to the conflict or dispute, in order to function and carry out their mandate, and are not intended or usually organized or equipped to engage in protracted hostilities or impose a solution militarily. Their primary purpose is to act in support of efforts aimed at promoting disengagement of the parties to a particular conflict and of achieving a diplomatic solution. Traditionally, the role and function of such operations was to act as a buffer between opposing forces after a ceasefire agreement had been reached and oversee and facilitate the carrying out of the terms of such agreements through monitoring, interposition, and persuasion. Since the end of the Cold War, these traditional tasks have been progressively expanded to include in many cases the promotion of a stable environment, the maintenance of public order, the provision of humanitarian assistance in cooperation with civilian governmental and non-governmental agencies, and the protection of civilians from violations of Humanitarian and Human Rights Law to the extent possible within the terms of their mandate and their operational capabilities. Peace operations are sometimes provided with mandates under Chapter VII of the UN Charter as an additional means of inducing compliance of the parties and signaling the resolve of the international community¹.

Peace operations in the strict sense as described above imply that the military forces involved operate below the threshold of armed conflict, in the sense that the Law of Armed Conflict, including the Geneva Conventions, does not apply to them.

The conference discussions will focus on legal rules, but equally on proposed good practices in the field of Peace Operations. Participants will profit from each other's knowledge, experience and perspective.

Furthermore, the conference will offer plenty of networking opportunities.

Subjects

Academic speakers and experienced professionals will address the following topics:

- The Legal Framework of Peace Operations
- The Threshold of Armed Conflict
- The Development of and Contemporary Challenges to International Humanitarian Law, in particular with respect to its Applicability and Application in the Context of Peace Operations
